ESSC exists to enrich the lives of our participants and strengthen the community fabric of the Mount Washington Valley. MWV programs offer premier coaching and instruction in skiing and snowboarding, and emphasize the values of Commitment, Teamwork and Integrity. We help shape the character of our youth, and every child in the MWV interested should be able to take advantage of the opportunities we provide, regardless of their financial situation. Because our funds are limited, scholarship assistance will be contingent upon financial need. Please understand that all MWV competition program participants receive a form of financial aid since program fees do not cover the true cost of providing these programs. All programs defray costs by hosting events and fundraisers.

CONDITIONS FOR SCHOLARSHIP AWARDS

All participants receiving a scholarship must meet the following conditions. Failure to meet these requirements will result in the forfeiture of the scholarship award.

- Recipients must abide by the ESSC Code of Conduct, be a resident of Carroll County and currently in grades three through twelve.
- All recipients will be required to write a letter of acceptance acknowledging they have been selected to receive this award
- All recipients will be required to write a letter of thanks on behalf of ESSC (post-season).
- A copy of the letter of thanks must be sent to ESSC to be eligible for scholarship in the following season.
- All past Program balances must be paid in full.
- Student/Athlete or family of recipient would volunteer and assist at ESSC fundraisers—ESSC Annual Ski Sale (November) and Red Parka Challenge Race (March).
- Recipient would be available for photo upon receiving support.
- Student/Athlete is committed to full attendance.

COMPLETED SCHOLARSHIP APPLICATION INCLUDES

- Scholarship Application Form – Only one form is required per family.
- 2022 Tax Returns – Two-parent households filing separate returns must attach 2023 tax returns from both individuals to be considered. All information is confidential.
- Explanatory Letter – On a separate sheet, please inform the scholarship committee, in approximately 250 words, as to why you are requesting a scholarship.
- Completed registration and deposit for program.
- Two recommendations (teacher/coach).

Please understand that scholarship funds are limited and allocated on financial needs. We will be awarding scholarships based on the tuition fees for the program you are participating in this season. Scholarship guidelines are: Skill development, up to 20%; USSA racing, up to 30%; USSA and FIS racing, up to 40%. In special circumstances we may be able to offer up to 50% of the program fees. Scholarship applicants should also thoroughly understand the conditions that accompany the receipt of an award. USSA racing is 30% for local mountain race programs, basically U10-U14 (non-scored racing – youth racing) CRT, WC, KP, Attitash; USSA and FIS racing is 40%, U16 and up athletes – scored racing.

All completed applications must be postmarked by October 11th, 2024.

SELECTION OF APPLICANT

Application must be fully completed to be eligible. Scholarship Committee will review applications and announce recipients in early November.
